This guide distills the seven strategies that separate effortless ownership from costly distraction. 01 **Treat Salt Air as an Active Adversary**

The Bahamian climate is unrelenting. Salt air, humidity, and UV exposure silently degrade fixtures, finishes, electronics, and HVAC systems long before owners notice. A quarterly preventive maintenance cadence — exterior wash-downs, anode inspections, AC coil treatments, and sealant audits — protects six- and seven-figure interiors at a fraction of remediation cost. Reactive maintenance is the single largest hidden cost of absentee ownership.

02 **Establish a Hurricane Readiness Protocol Before June 1st**

Hurricane season runs June 1 through November 30. The owners who fare best are those whose properties have a documented, rehearsed protocol: storm shutters tested annually, generators load-tested monthly, fuel contracts pre-arranged, vessels hauled or relocated on a defined trigger, and a chain-of-command for shutter deployment. Insurance carriers increasingly require evidence of these measures for full payout.

03 **Demand Institutional-Grade Financial Reporting**

Your property is an asset on your balance sheet. It deserves the same reporting rigor as any other investment: monthly profit-and-loss statements, accrual-based accounting, 1099 generation, and an owner portal with 24/7 access to ledgers, leases, and maintenance histories. If your current manager cannot produce a tax-ready statement on demand, you are exposed.

04 **Vet Tenants With the Same Discipline as a Wealth Advisor**

A single poorly-screened tenant can erase a year of rental income through damage, eviction proceedings, and lost reputation. Premium tenant selection requires credit, criminal, eviction, employment, and reference checks — every time, without exception. The rental yield premium of a Bahamian luxury property is sustained by tenant quality, not advertising.

05 Consolidate Vendors Under One Accountable Point of Contact

Most absentee owners manage a fragmented roster: one landscaper, one pool tech, one housekeeper, one electrician, each invoicing separately and coordinating poorly. The hidden cost is your time and the gaps between them. A single management partner who orchestrates, audits, and absorbs vendor risk transforms ownership from a part-time job back into a pleasure.

06 Document Everything — Photographically and Continuously

Condition reports, inspection photographs, inventory registers, and serial numbers should be captured at onboarding and refreshed quarterly. This documentation is your defense in insurance claims, tenant disputes, and resale negotiations. It is also how a true guardian demonstrates that nothing has slipped between visits.
